

**CITATION**  
**FAILURE TO FILE 2013 ANNUAL REPORT - A.R.S. § 45-632**

Pursuant to A.R.S. § 45-632(O) an Annual Water Withdrawal and Use Report ("Annual Report") for the above listed right or permit must be filed no later than March 31 of each year for the preceding calendar year. The Annual Report must be filed regardless of whether or not the right or permit was utilized. The Annual Report for the permit number listed above has not been filed by the statutory deadline.

You are hereby afforded an opportunity to avoid further sanctions by signing the agreement at the bottom of this document, preparing the subject Annual Report and returning these documents to the mailing address listed above with the following fees and payments: (1) a late filing fee of \$150.00 (A.R.S. § 45-632(O)); (2) if groundwater was withdrawn in 2013, applicable withdrawal fees and a late payment penalty fee of 60% of the withdrawal fee (A.R.S. § 45-614(E); if applicable, Water Quality Assurance Revolving Fund (WQARF) fees (A.R.S. § 45-616); and a civil penalty of \$250.00;

If you comply with all financial and reporting requirements described above and return all forms and fees no later than December 15, 2014, the Department of Water Resources will not take further enforcement action associated with this Citation. Failure to comply with these requirements may result in further enforcement action, including seeking additional civil penalties pursuant to A.R.S. § 45-635(A) (1) in an amount up to \$100.00 per day for delinquent Annual Report filing.
