#### FAILURE TO FILE 2013 ANNUAL REPORT - A.R.S. § 45-632

Pursuant to A.R.S. § 45-632(O) an Annual Water Withdrawal and Use Report ("Annual Report" ) for the above listed right or permit must be filed no later than March 31 of each year for the preceding calendar year. The Annual Report must be filed regardless of whether or not the right or permit was utilized. The Annual Report for the permit number listed above has not been filed by the statutory deadline.

You are hereby afforded an opportunity to avoid further sanctions by signing the agreement at the bottom of this document, preparing the subject Annual Report and returning these documents to the mailing address listed above with the following fees and payments: (1) a late filing fee of \$150.00 (A.R.S. § 45-632(O); (2) if groundwater was withdrawn in 2013, applicable withdrawal fees and a late payment penalty fee of 60% of the withdrawal fee (A.R.S. § 45-614(E); if applicable, Water Quality Assurance Revolving Fund (WQARF) fees (A.R.S. § 45-616); and a civil penalty of \$250.00;

If you comply with all financial and reporting requirements described above and return all forms and fees no later than December 15, 2014, the Department of Water Resources will not take further enforcement action associated with this Citation. Failure to comply with these requirements may result in further enforcement action, including seeking additional civil penalties pursuant to A.R.S. § 45-635(A) (1) in an amount up to \$100.00 per day for delinquent Annual Report filing.

**FINAL NOTICE OF VIOLATION**  
**Of A.R.S § 45-632 or A.R.S § 45-875.01**  
**Failure to File 2013 Annual Report**

Arizona Department of Water Resources ("Department") records indicate that the 2013 Annual Report for the right or permit listed above has not been filed. The Annual Report must be filed with the Director of the Department no later than March 31st of each year for the preceding calendar year. The Annual Report must be filed regardless of whether or not water was used pursuant to the right or permit. You are in receipt of this Notice of Violation for failure to file an Annual Report for one of the following statutes:

- Pursuant to A.R.S. § 45-632(O) an Annual Water Withdrawal and Use Report must be filed no later than March 31 of each year for the preceding calendar year. This includes Annual Reports filed for service area rights, grandfathered groundwater rights, groundwater withdrawal permits, irrigation district and BMP groundwater summaries, recovery well reports and BMP enrollees, among others.

The penalty for failure to file an Annual Report pursuant to A.R.S. § 45-632(O) is \$25.00 for each month or portion of a month that the Annual Report is delinquent. The total penalty assessed for violations of A.R.S. § 45-632(O) shall not exceed \$150.00. If groundwater was withdrawn in 2013, you are also subject to a late payment fee of ten percent of the unpaid groundwater withdrawal fee for each month or portion of a month that the Annual Report is delinquent, not to exceed sixty percent of the unpaid fee. A.R.S. § 45-614(E). Water Quality Assurance Revolving Fund fees for groundwater withdrawals, if applicable, are also due at this time. A.R.S. § 45-616.

Or

- Pursuant to A.R.S. § 45-875.01, an Annual Water Withdrawal and Use Report must be filed no later than March 31 of each year for the preceding calendar year. This includes Annual Reports for water storage facility permits, e.g., GSF, USF, UWS and WS summaries, among others.

The penalty for failure to file an Annual Report pursuant to A.R.S. § 45-875.01(E) is \$25.00 for each month or portion of a month that the Annual Report is delinquent. The total penalty assessed for violations of A.R.S. § 45-875.01(E) shall not exceed \$150.00.

If your report is not received by September 30, 2014, the Department of Water Resources may issue a Citation to you for the failure to file the Annual Report for calendar year 2013. In addition to the late fees already accrued, a civil penalty of \$250.00 will be assessed. You are urged to complete and file your 2013 Annual Report in order to avoid enforcement action.
