

NOTICE OF INTENTION TO DRILL OR DEEPEN AN EXEMPT WELL

Section 45-596, Arizona Revised Statutes, provides: A person may not drill or cause to be drilled any well or deepen or replace an existing well without first filing a Notice of Intention to Drill with the Department on a form prescribed and furnished by the Department. The well shall be completed within one year after the date of Notice. An exempt well means a well having a pump with a maximum design capacity of not more than 35 gallons per minute which is used to withdraw groundwater. An exempt well may include the non-commercial irrigation of not more than 1 acre of land.

Dear Sir:

By this letter, we are transmitting to you an annotated copy of the Notice of Intention to Drill an Exempt Well along with associated forms for your records.

The purpose of this special letter is to advise you of the law relating to this type of exempt well which you intend to drill in the PHOENIX Active Management Area.

Because of the non-private residence, household, stockwatering nature of your proposed use, the well is limited to a total pumpage of 10 acre feet per annum. You may equip the well to pump a maximum of 35 gallons per minute or less, but are limited to a pumping schedule so as not to pump more than 10 acre feet total in a year. This change of law occurred on April 28, 1983, as reflected in Senate Bill 1392, ARS 45-454B.

Dear Mr. Ricker:

By this letter we are transmitting documents relating to the drilling of the referenced eight wells. These wells are being approved for drilling as exploration wells for monitoring purposes under the provisions of the Department's Draft Rule R12-15-802.

Authority is granted to drill and operate these eight wells under the following conditions as stated in your letter of August 25, 1983:

1. No pump equipment shall be installed in the wells and no pumping of groundwater is required or authorized.
2. Each well shall be abandoned when it is no longer needed for monitoring purposes (to observe the level of groundwater if encountered) by the Arizona Department of Transportation in accordance with the provisions of R12-15-816 and so reported to this Department.
